Instruction Manual For MetaTrader 4 Users

Introduction:

Welcome and we know you are excited to get going with your new software by TradersCoach.com®. Please read this entire manual before installing and using your new TradersCoach.com software.

The software installation package includes the following:

The following studies “Plug-into” the MetaTrader 4 (MT4) charting platform.

- **ART® Trading Software**
- **Optimum Wave Locator (OWL) Indicator Software**
- **Precision Trend Filter (PTF) Indicator Software**

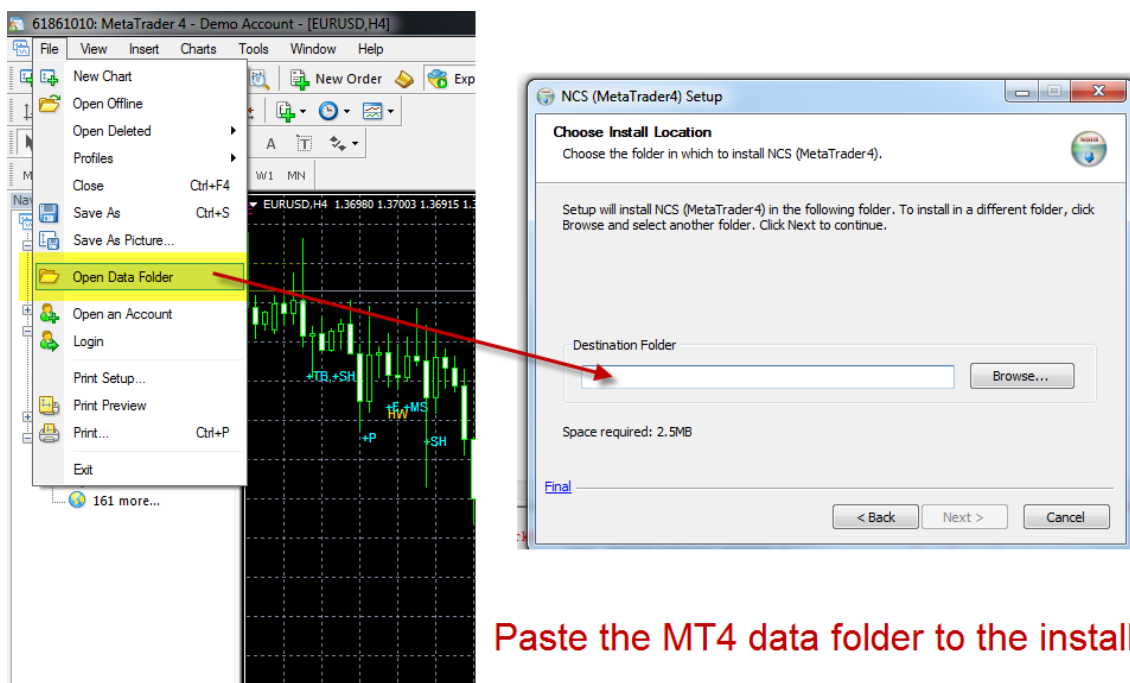
This manual covers all aspects of the software included in your download. We have included information on how to use each software study on the MetaTrader 4 charting platform. In addition we have included additional resources to help you learn how to be a successful trader.

When you install this software package, you will have full software functionality for 10-Days without having to obtain an activation code. During this 10-day trial period you will have the option to purchase or lease the entire suite of software or just individual studies. To get the most from your 10-Day Trial, we invite you to attend our Weekly Client Support Webinars and view the recording which will help you learn how to use it.

Installation Steps:

Use these steps to install the TradersCoach.com software into your MetaTrader 4 platform.

- 1) Turn off your virus & security software. Note: Depending on how strict your PC security settings are, you may get security warnings (not digitally signed, about to install and exe file, etc.) asking you if you are sure you want to proceed with the installation, click “YES” or “OK” and proceed. All TradersCoach.com software is virus free and safe.
- 2) Download the TradersCoach.com® (TC) software set-up installation file to your desktop or to an area on your computer where you can find this file.
- 3) **Have your MetaTrader 4 Charting Platform OPEN** and close all OTHER software programs.
- 4) Find the TC Software Installation file you downloaded to your PC. Double-click or open the TC Software set-up installation file to begin the installation process. An installation Wizard will appear guiding you through the installation process.
- 5) **IMPORTANT:** During the installation, when you get to the section of choosing the “Destination Folder”, you need to select the MT4 “**Open Data Folder**”. To find this folder, go to your open MT4 charting platform, Go to “File” at the upper right side of MT4. In the “File” drop-down menu, choose the “Open Data Folder” in MT4. The location will now be visible. MT4 will open the folder itself and you can copy and paste the path to the installer’s “Destination Folder” field. **Next CLOSE the MT4 charting platform now and then click the “Next” button on the installer.** See diagram below:

- 6) Be sure you CLOSE MT4 charting platform. The MetaTrader 4 charting platform will now need to be closed at this time, and during rest of the installation.
- 7) After you finish installing the TC Software and close out of the installation wizard, start NinjaTrader.
- 8) To load the TradersCoach.com Software Studies onto your MetaTrader 4 charts, see the accompanying manuals for specific studies.

TradersCoach.com Software Activation After 10-Day Grace Period:

After you install the TradersCoach.com software for the first time it will run for 10-Days without activation. Some may wish to use this 10-Day period as a trial, others may use it as a grace period awaiting their activation code. Regardless, on the 11th Day the software will ask you for an unlock code.

To obtain an unlock activation code, you must either purchase or lease the software. If you already purchased you should have received your activation code via email. If you cannot find your activation code or lost it, you need to [CLICK HERE](#) and fill out the online activation request form to have your unlock activation code emailed to you.

Once you purchase or lease the software, you will automatically receive your activation code via email after you complete your order, but the only way to enter your software activation code is after the 10-day grace period is over and the software asks you for your activation code. So when you receive your activation code via email you will need to save it until the software asks you to enter it at the end of the 10-day grace period. There is no way to enter your activation code until the 10-day grace period is over.

End-of-Trial TradersCoach.com Software Purchase Options:

Once your 10-Day Trial has finished you will need to either purchase or lease the software you want from TradersCoach.com. You may purchase or lease the entire bundle or suite of studies or purchase or lease them individually.

During your 10-Day Trial you should have received emails from TradersCoach.com explain how to purchase the software you want and a link to our online store. [CLICK HERE](#) to access the TradersCoach.com Online Store.

Please note that after the 10-Day Trial the TradersCoach.com software will stop working unless you insert a permanent unlock code. The software will alert you with a pop-up window box alerting you that your 10-Day Trial is over and you need to purchase now. This pop-up window

box will also ask you to insert your unlock code provided by TradersCoach.com if you have one. Once inserted you will then be activated and can continue to use the software.

If you do not purchase the software, then you will need to remove the TradersCoach.com software studies from your charts or you will continue to get an alert that your 10-Day Trail has expired. You can also remove all the TradersCoach.com software from TradeStation using TradeStation's "EasyLanguage Editor" and deleting all the TradersCoach.com studies. This will remove it from TradeStation completely.
